Please be advised that the San Bernardino County, Department of Public Health, Division of Environmental Health Local Enforcement Agency (LEA) received and accepted a Report of Facility Information (RFI) amendment to the Joint Technical Document (JTD) for the Victorville Sanitary Landfill. The Victorville Sanitary Landfill is located at 18600 Stoddard Wells Road, Victorville, CA 92307.

On December 26, 2025, the LEA received an application package to process a RFI amendment for the Victorville Sanitary Landfill, SWIS No. 36-AA-0045.

The changes include the following:

- Updates to the table of contents including page number corrections and updates to the appendix list
- The addition of a statement stating that if any loads of compost mid-fraction visually appear to contain more than 10 percent inert materials they will be rejected or disposed of at the active face

The LEA finds that the proposed change is consistent with all applicable CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facility permit. The LEA accepted the RFI amendment on January 22, 2026.
