Please be advised that the County of San Bernardino, Department of Public Health, Division of Environmental Health Services Local Enforcement Agency (LEA) received an application for modification to the Solid Waste Facility Permit (SWFP) for the Victor Valley Regional Composting Facility. The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle), to enforce state laws and regulations at solid waste sites within the County of San Bernardino.

Description of Project and LEA's Preliminary Determination

The Victor Valley Regional Composting Facility is located at 20055 Shay Road, Victorville. On March 7, 2019 the LEA received from Victor Valley Regional Composting Facility a Solid Waste Facility Permit (SWFP) modification package to amend the RCSI and permit to remove Biosolids from the prohibition section on the permit, and to allow intake of Class A Biosolids from the adjacent Victor Valley Wastewater Reclamation Authority (VWRA) so as to be used as an amendment, as described in the RCSI.

The changes include:

- Construction of a new storm water basin, concrete composting pad, and processing building
- Background information, Description of Composting Processes
- Addition of Monitoring and Testing for Physical Contaminants
- Alternative and Existing Processing Equipment

The LEA determines that the proposed change is a nonmaterial change as specified in 21563(d)(5) and that the proposed change is such that the solid waste facilities permit does not need to include further restrictions, prohibitions, mitigations, terms, conditions or other measures to adequately protect public health, public safety, and the environment.
