Please be advised that the County of San Bernardino, Department of Public Health, Division of Environmental Health Local Enforcement Agency (LEA) received and accepted a Report of Facility Information (RFI) amendment for the Big Bear Transfer Station. The LEA is certified by

the California Department of Resources, Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within the County of San Bernardino, including all solid waste transfer stations.

Description of Project and LEA's Preliminary Determination

Big Bear Transfer Station is located on 38550 Holcomb Valley Road, Big Bear, CA 92314. On April 28, 2021 the LEA received a Solid Waste Facility Permit (SWFP) application package from the Big Bear Transfer Station to amend the Transfer Processing Report (TPR) in a form of an RFI amendment, to update information based on "Findings" identified during the facility's 5-Year Permit Review. The changes included updates to current information and language in the Transfer Processing Report (TPR).

The LEA finds that the proposed change is consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA accepted the amendment on May 27, 2021
