Please be advised that the County of San Bernardino, Department of Public Health, Division of Environmental Health Services – Local Enforcement Agency (LEA) received and approved a Report of Facility Information (RFI) amendment to the Transfer/Processing Report (TPR) for the Advance Disposal Center For The Environment. The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle), to enforce state laws and regulations at solid waste sites within the County of San Bernardino, including all active transfer stations.

Description of Project and LEA’s Preliminary Determination

Advance Disposal Center for the Environment is located at 17105 Mesa Street, Hesperia, California. On October 28, 2019 the LEA received, from Advance Disposal, a Solid Waste Facility Permit (SWFP) application package to amend their TPR in the form of an RFI amendment. The changes include the following:

- Updates to incorporate a new piece of MRF equipment, the TORXX Kinetic Pulverizer, in an effort to meet the requirements of the state organic waste diversion mandates.

The LEA finds that the proposed change is consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA approved the amendment on November 27, 2019.
