Please be advised that the County of San Bernardino, Department of Public Health, Division of Environmental Health Services – Local Enforcement Agency (LEA) received and accepted a Report of Facility Information (RFI) amendment to the Joint Technical Document (JTD) for the California Street Landfill. The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle), to enforce state laws and regulations at solid waste sites within the County of San Bernardino, including all active and closed landfills.

Description of Project and LEA's Preliminary Determination

California Street Landfill is located at 2151 Nevada Street, Redlands, California. On October 4, 2019 the LEA received, from California Street Landfill, a Solid Waste Facility Permit (SWFP) application package to amend their JTD in the form of an RFI amendment. The changes include the following:

- Updates to various pages within the document including a description of existing on-site and off-site detection systems with respect to locations of structures and buildings within 1,000 feet of the landfill boundary.
- Updates to maps indicating current locations of landfill gas monitoring probes.
- Edits to Appendix R “LFG Probe Logs”, Appendix S “Load Checking Program, and Appendix U “Green Waste Chipping and Grinding Activity Plan”.
- Addition of language describing the new Chipping and Grinding Activity (excluded activity). Language has been added to the JTD to indicate that under 14 CCR Section §17855 (a)(5)(J), the proposed chipping and grinding activity is excluded, stating, “the material will be handled in such a way as to preclude their reaching temperatures at or above 122 degrees F”, and that the chipping and grinding activities will take place within the permitted landfill and will share equipment and personnel at said landfill. The city is proposing to use the processed ground material as beneficial reuse at the landfill for erosion control. In addition, an edited Section 1.0 of the Preliminary Closure/ Post-Closure Maintenance Plan has also been included.

The LEA finds that the proposed change is consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA accepted the amendment on November 4, 2019.
