Please be advised that the County of San Bernardino, Department of Public Health, Division of Environmental Health Services – Local Enforcement Agency (LEA) received and approved a Registration Permit Tier for a Vegetative Food Material Composting Facility (VFMCF) for Huerta del Valle Ontario Carbon Farm (HDV). The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle), to enforce state laws and regulations at solid waste sites within the County of San Bernardino, including all active composting operations and facilities.

Description of Project and LEA's Determination

Huerta del Valle Ontario Carbon Farm Composting Facility is located at 13345 Walker Avenue, Ontario CA, 91761. On December 10, 2019 the LEA received, from HDV, the official submittal of an application for a Registration Permit in a CIWMB Form 83(rev. 12/96). The submittal for a Registration Permit as a VFMCF will allow HDV to receive up

to 10 tons per day of compost feedstock. The feedstock may include vegetative food material, manure, agricultural material, and green material.

The Facility will operate from 6:30 AM to 4:00 PM October through March (winter hours), and 6:30 AM to 7:30 PM April through September (summer hours). This Facility will not be open to the public. There will be approximately 6 to 7 truck trips to the site daily, Monday through Friday. The Facility will be closed on the following holidays: Christmas, New Year's Day, Memorial Day, and Labor Day.

Huerta del Valle Ontario Carbon Farm Composting Facility shall follow all minimum standards applicable to it, as set forth in Title 14, Division 7 of the California Code of Regulations (CCR), including but not limited to the following:

- Title 14, Division 7, Chapter 5 Article 3, (Regulatory Tier Requirements) and
- Title 14, Division 7, Chapter 3.1 Articles 5, 6, 7, 8, and 9 (Compostable Materials Handling Facility Regulatory Requirements)

The LEA accepted the application as complete and correct and approved the facility to operate as a VFMCF on January 9, 2019.
