Please be advised that the County of San Bernardino, Department of Public Health, Division of Environmental Health Local Enforcement Agency (LEA) received and accepted a Report of Facility Information (RFI) amendment to the Joint Technical Document (JTD) for the Barstow Sanitary Landfill. The LEA is certified by the California Department of Resources, Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within the County of San Bernardino, including all active and closed landfills.

Description of Project and LEA's Preliminary Determination

The Barstow Sanitary Landfill is located at 32553 Barstow Rd. in Barstow, CA 92311. On March 15, 2021, the LEA received, from the operator of Barstow Sanitary Landfill, a Solid Waste Facility Permit (SWFP) application package to amend the JTD.

The changes include the following:

- Updates to language within the JTD to reflect changes in design and operation of the site in relation to the Phase 1b liner area excavation and extraction including a refuse prism slope stability report.
- Updated configuration of the Phase 1b liner area.
- Updated JTD figures updated including site facility plan, excavation and Fill Plans, Master LCRS layout Plan and existing and final landfill gas control system plans.
- Addition of Phase 1B liner construction projects figures.
- Updates to information regarding environmental control systems.

The LEA finds that the proposed changes are is consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA accepted the amendment on April 14, 2021.
