Please be advised that the San Bernardino County, Department of Public Health, Division of Environmental Health, Local Enforcement Agency (LEA) received and approved a Registration Permit Application for Re:Circle Ontario LLC , SWIS No. 36-AA-0504. Re:Circle Ontario LLC is located at 170 N. Turner Ave. Ontario, CA 9176.

Description of Project and LEA's Determination:

Re:Circle Ontario LLC approved activities include receipt, processing, and transfer of materials including recyclables, organics, and beverage containers with contents. The facility is permitted to receive 99 tons per day. The facility operates on 2.85 acres and operates Monday- Sunday. The facility is permitted to receive 105 incoming vehicles per day and 62 outgoing vehicles per day.

Re: Circle LLC Ontario shall follow all minimum standards applicable to it, as set forth in Title 14, Division 7 of the California Code of Regulations (CCR), including but not limited to the following:

- Title 14, Division 7, Chapter 5 Article 3, (Regulatory Tier Requirements) and
- Title 14, Division 7, Chapter 3 Articles 6.0, 6.1, 6.2, 6.3, and 6.35 (Transfer Processing Facility Regulatory Requirements)
- Monthly recordkeeping reporting of all sections in Article 6.3 – Section 17414 to the LEA due within ten (10) days from the following month.

The updated Transfer Processing Report (dated June 2025) includes the following section updates:

- Number and Type of Vehicles
- Material Receiving and Staging
- Cleaning
- Drainage Control
- Dust Control
- Hazardous, Liquid, and Special Waste
- Maintenance Program
- Protection of Users
- Measuring Organic Waste
- Vector, Bird, and Animal Control
- Site Attendant
- Site Map

The LEA finds that the application complete and correct on July 24, 2025.
