Please be advised that the San Bernardino County Solid Waste Local Enforcement Agency (LEA) received and accepted a Report of Facility Information (RFI) amendment for Apple Valey Solid Waste Disposal Facility (Facility). The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle), to enforce state laws and regulations at solid waste sites within San Bernardino County, including all active and closed landfills.

Description of Project and LEA's Preliminary Determination

The Facility is located at Yucca Loma Road, Apple Valley, CA 92307. On July 24, 2024 the LEA received a Solid Waste Facility Permit (SWFP) application from the Facility. The SWFP application included a proposed RFI amendment to update information in the current RFI based on findings identified during the Facility's 5-Year Permit Review. The changes include:

- Responses to LEA Findings per the Permit Review Report, dated April 28, 2024 which include:
 - Update to the PCMP to address the ongoing illegal dumping issues, expanding on the current procedures in place such as site security enhancement, response and clean up procedures
 - Update to section 3.2 Ground Water/Vadose Zone Monitoring System and Appendix D of the PCMP in regard to changes to the groundwater monitoring system.
- Revised Financial Assurance for Known or Reasonably Foreseeable Release (Geo-Logic Associates, 2024), which is included as Appendix R of the PCMP.

The LEA finds that the proposed change is consistent with all applicable certified and/or adopted CEQA documents, is consistent with state minimum standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA approved the amendment on August 23, 2024.
