Please be advised that the San Bernardino County Solid Waste Local Enforcement Agency (LEA) received and approved a Report of Facility Information (RFI) Amendment for the Yermo Disposal Site (SWIS# 36-AA-0047). The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within the San Bernardino County, including all active and closed landfills.

Description of Project and LEA's Preliminary Determination

The Yermo Disposal Site is located at 40950 Minneola Road, Yermo, California 92398. On July 24, 2024, the LEA received an RFI Amendment Application Package to address the "Findings"

identified during the facility's Five-Year Permit Review. The amendment package included the following:

- Completed and signed Application for Solid Waste Facility Permit and Waste Discharge Requirements (CalRecycle Form E-1-77)
- Responses to LEA Findings per the Five-Year Permit Review Report
- Electronic copy of the complete Post Closure Maintenance Plan (PCMP)
- Electronic copy of the "Track Changes" format of the PCMP

The LEA finds that the proposed changes are consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA accepted the RFI Amendment on August 23, 2024.
