Please be advised that the San Bernardino County Solid Waste Local Enforcement Agency (LEA) received and accepted a Report of Facility Information (RFI) amendment to the Report of Composting Site Information (RCSI) for Nursery Products Hawes Composting Facility (Facility). The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle), to enforce state laws and regulations at solid waste sites within San Bernardino County, including all composting operations and facilities.

# Description of Project and LEA's Preliminary Determination

The Facility is located at 14479 Cougar Road, Helendale, CA 92342. On February 3, 2023 the LEA received a Solid Waste Facility Permit (SWFP) application from the Facility. The SWFP application included a proposed RCSI to update information in the current RCSI and expand mitigation and monitoring methods used by the Facility based on findings identified during the Facility's 5-Year Permit Review. The changes include:

- Additional mitigation methods for litter and compost contamination;
- Addition of a complaint website https://nurseryproducts.com and the phone number for the complaint hotline at 760-881-5247;
- Addition of the Fire Prevention Plan attached to the RCSI as Exhibit 1;
- Improved Site Plan that complies with the local fire agency;
- Physical contamination compost sampling;
- Compost sampling frequency to be more aligned with the requirements; and
- Other clarifications and corrections for consistency.

The LEA finds that the proposed change is consistent with all applicable certified and/or adopted CEQA documents, is consistent with state minimum standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA approved the amendment on February 23, 2023.
