Please be advised that the County of San Bernardino Solid Waste Local Enforcement Agency (LEA) received and approved a Report of Facility Information (RFI) amendment to the Transfer Processing Report (TPR) for Advance Disposal Center for the Environment (Advance Disposal). The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle), to enforce state laws and regulations at solid waste sites within the County of San Bernardino, including all active and closed landfills.

## Description of Project and LEA's Preliminary Determination

Advance Disposal is located at 17105 Mesa Street, Hesperia, CA 92345. On November 11, 2022, the LEA received, from Advance Disposal, a Solid Waste Facility Permit (SWFP) application package to amend the TPR to update information in the current TPR based on "Findings" identified during the facility's 5-Year Permit Review. The changes include:

- Updated phone number for San Bernardino County Division of Environmental Health Services
- Typo corrections within the document
- Updated baler type and specifications
- Updated 48 hours to 7 days for consistency in green material storage times between TPR and Odor Impact Minimization Plan
- Removed "demo" project description and associated Appendix C

The LEA finds that the proposed change is consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA approved the amendment on December 9, 2022.
